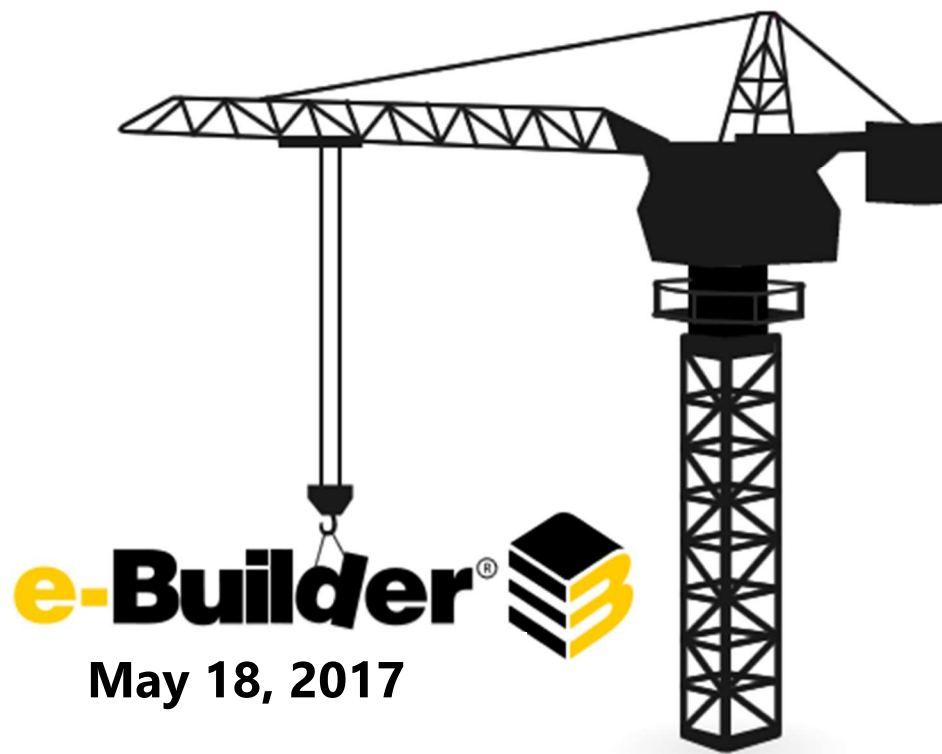

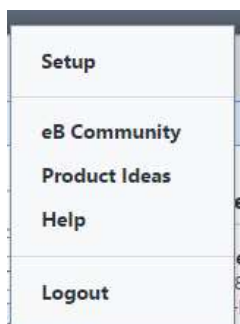

## Bidding

### Case Number: 00218277

BID QUESTIONS ARE SHOWING ON QUESTIONS TAB IN HISTORY

The problem was that the bid messages with a certain value were not being pulled into the history. A script has been run to fix this issue.

## Calendar

### Case Number: 00216565

ORGANIZER UNABLE TO EDIT MEETING MINUTES

The data stored for meeting items had bad data that created the issue where it wouldn't allow the edit function to execute. A data fix has been made and edits can now be done by the organizer.

## Cost

### Case Number: 00209668

UNABLE TO SAVE FORECAST FOR CERTAIN MONTHS

There were some months that had duplicate data. This data fix remove the duplicate months for all the projects in the account.

### Case Number: 00211908

VOIDED COMMITMENT CHANGE IS STILL LISTED IN CURRENT COMMITMENT VALUE

When a commitment change was voided, it continued to be listed in current commitment value. A data fix has been deployed to update the commitment item.

### Case Number: 00215144

LINE ITEMS FROM DIFFERENT COMMITMENTS AND DIFFERENT VENDORS CAN BE ADDED TO A COMMITMENT CHANGE

Previously, when users changed the selected commitment after adding items to the change items grid, the grid would not refresh allowing users to create commitment changes with items from multiple commitments. Now, the grid will be cleared after each commitment is selected..

## Documents

### Case Number: 00214581

PRESENCE OF % SIGN PREVENTED LOAD OF THE MARKUP WHEN REVIEWED

Previously, presence of % sign in markup name didn't load the markup when reviewed. Now the fix is implemented so that the % sign will not affect opening up the markup.

### Case Number: 00213272

ADD FOLDER DESCRIPTION ADDED TO TOOL TIP

When hovering a folder in the Documents tree it only showed the count file in the tooltip. Now, we add the folder description to the tooltip. If the user configures the option "Include Files in Subfolders in Folder File Counts" to Yes, we also add the file count to the folder and the tooltip. The option "Include Files in Subfolders In Folder File Counts" is in Setup/Preferences/Interface Settings

**Case Number: 00212878**

SUB-FOLDERS ARE OUT OF ORDER

Previously, when a folder or file was being inserted underneath a parent folder the sub-folders were listed out of order. Now the folder or file is inserted in the proper position

## Processes

**Case Number: 00218027**

PROCESS STUCK IN START STEP

When evaluating data field assignments, if a date without a value was part of the expression being evaluated an error would result preventing workflows from advancing. This evaluation error has been corrected and values are assigned appropriately and workflows with this scenario can again proceed.

## Reports

**Case Number: 00214340**

UNABLE TO LOAD REPORT WITH 16,000+ ROWS OR DATA

The UI was failing to load a report with 160 000+ rows. The row counting check was updated to show only a partial view of the report despite the check details is selected if the amount of information is too big. Now it will show the partial view despite if the “show details” is selected or not.

EXCEL EXPORTS NOT DISPLAYING STRIKETHROUGHS, BREAK LINES, AND SPACES

Previously, Excel exports from e-builder standard reports were not displaying strikethroughs, break lines, and spaces. Now the new code allows export to a report to excel with strikethrough style, break lines and spaces.

**Case Number: 00187972**

FILTER ON SPECIFIC DATE NOT WORKING

Previously, the filter in the report didn't work properly because processes were assigned a time component to the Date data field when it had the 'Today()' expression- which should only save

the date. Now the time component was removed from the data field that belong to the specific process in the case that was assigned the expression 'Today()'.

## Schedule

### Case Number: 00203068

SCHEDULE IMPORT FAILURE .MPP FILES INTO E-BUILDER

Previously, when attempting to import a .mpp file into the e-builder schedule module, most tasks with 0% completion would not honor the start/finish dates in the import file and would instead apply the current date to them. This was due to the constraint types not properly being handled during the import.

### Case Number: 00211722

SCHEDULED TASK - IMPORT VALIDATION ERROR

The system wasn't validating if some columns exists on a file to import, before use those columns. Now the validation is performed before using them.

## Setup Admin

### Case Number: 00214501

MASTER COMMITMENT PROCESS IMPORT UPDATE

When importing into a Master Commitment Process to update the Master Commitment, the system was showing an exception that the Master Commitment number is not unique, and does not perform the update. Now the system performs the update without showing the invalid exception.

## System

### Case Number: 00215623

CONVERSION SERVICE ERRORS ON EXPORT

Previously there were errors in converting some files when exporting information. Changes have been made to allow additional files to successfully by converted to pdf files for viewing.

## User Setup

**Case Number: 00211904**

UNABLE TO CHECK ALL PROJECTS UNDER MANAGE BILL RATES

Previously, when attempting to save bill rates when more than 100 projects existed on multiple pages, only the currently viewed page would be saved and all others would be erased. Now, all bill rates across pages will be saved.
